Crafter understands and agrees to the following:

1. **COMMERCIAL PRODUCTS:** Hand crafted items are highly preferred for this show. However, no commercial products are to be sold without the approval of the sponsor. The sponsor reserves the right to prohibit the sale of any items that are not approved. This does not apply to raw materials used in the making of a craft item. **The discretion of NAPA representatives will prevail.**
2. **Crafter is not permitted to sell any type of food or drink**, with the exception of homemade candy that has been pre-approved by NAPA. **This includes Baked Goods.**
3. **Crafter is not permitted** to sell **any** type of **chances** or conduct **any** type of **“lottery”** for his/her merchandise.
4. **Crafter** agrees to **DONATE** a **handmade** craft valued at a minimum of \$20 for each space rented. The item(s) must be represented on Crafter’s display area for patrons to purchase.
5. **Crafter** agrees to deliver the donated **handmade** craft item(s) between **4:00 P.M. and 6:00 P.M. on Friday, October 10, 2008**, or between **7:00 A.M. and 8:30 A.M. on Saturday, October 11, 2008** at which time a receipt will be given for the item(s) and space assignments will be given.
6. **Crafter** agrees to hold **Nazareth** and **NAPA** **harmless for any theft or damage to crafts displayed or damage to personal property or persons.**
7. **Crafter** understands that spaces with electrical outlet access are limited and preference will be given to Crafters having had those spaces in previous years.
8. **Crafter** must sign and return the attached Indemnification with this Crafter Agreement/Entry Contract.
9. **Crafter** participates in the Craft Show at the complete discretion of NAPA and its representatives. Any behavior or conduct (by the Crafter or by assistants or helpers of the Crafter) deemed unacceptable by a NAPA representative shall be grounds for removal of the Crafter from the Craft Show.
10. **Crafter assumes responsibility** for any and all assistants, associates or helpers participating with Crafter in the Nazareth Holiday Craft Show.
11. **By signing this Contract, Crafter acknowledges and agrees to all of the provisions hereof.**
