

INDEMNIFICATION

THIS INDEMNIFICATION AGREEMENT (“Agreement”) is provided this _____ day of _____, 2008, by the undersigned (the “Crafter”) for the benefit of Nazareth Academy High School (“Nazareth”) and its affiliate Nazareth Academy Parents’ Association (“NAPA”).

The Crafter will be renting space at Nazareth as a commercial participant in the Nazareth Holiday Craft Show which is organized by NAPA. As an inducement to Nazareth and NAPA to agree to rent space to the Crafter and permit the Crafter to participate in the Nazareth Holiday Craft Show, the Crafter has agreed to indemnify and hold harmless Nazareth and NAPA and all of their respective officers, directors, affiliates, employees and agents (collectively, the “Indemnified Persons”) from any and all claims, damages, demands, liability and obligations relating to or arising from the Crafter’s participation in the Nazareth Holiday Craft Show.

NOW, THEREFORE, in consideration of the renting of space for participation in the Craft Show and other good and valuable consideration, and intending to be legally bound hereby, the Crafter does hereby agree as follows:

1. Indemnification and Hold Harmless. Crafter does hereby agree to indemnify and hold each of the Indemnified Persons harmless from and against any and all claims, liabilities, damages to persons or property, obligations, payments and expenses (including reasonable attorney’s fees) (each a “Claim”) which may arise from or in any way relate to Crafter’s participation in the Nazareth Holiday Craft Show, including any such Claim (i) that may be or is alleged to have been caused by the negligence or more culpable conduct of Nazareth , NAPA or any other Indemnified Person or (ii) that may be brought by, on behalf of, or otherwise arises from or is related to the acts or omissions of, any employee, agent, contractor, assistant, associate, helper, or others involved with Crafter in the Nazareth Holiday Craft Show.

2. Governing Law; Jurisdiction. The Crafter agrees that his or her obligations under this Agreement shall be governed by, and construed in accordance with, the laws of the Commonwealth of Pennsylvania without regard to its conflict of laws provisions. Any action or proceeding seeking to enforce any provision of, or based on any right arising out of, this Agreement may be brought in the courts of the Commonwealth of Pennsylvania, County of Philadelphia, or, in the United States District Court located therein, and the Crafter consents to the jurisdiction of such courts (and of the appropriate appellate courts) in any such action or proceeding and waives any objection to venue laid therein.
